The Saudi Center for Commercial Arbitration is organizing the 5th SCCA International Arabic Moot. The competition is directed to undergraduate students in the Sharia and law schools in all interested universities around the globe. The participants will compete by arguing, in Arabic, a hypothetical commercial arbitration case that simulates international commercial cases, thus honing the legal and personal skills that participants need to argue in front of international arbitration tribunals. The SCCA Arabic Moot will also enhance the participants' personal, cognitive, and legal abilities, as well as highlight their capabilities and allow them to compete on an international stage. Preliminary rounds will be held virtually via Zoom between 10-15 February 2024 while the advanced rounds (top 32 teams) will be held in-person in Riyadh, Saudi Arabia between 3-7 March 2024.
