The Saudi Center for Commercial Arbitration is organizing the 7th SCCA International Arabic Moot (SIAM6). The competition is directed to undergraduate students in the Sharia and law schools in all interested universities around the globe. The participants will compete by arguing, in Arabic, a hypothetical commercial arbitration case that simulates international commercial cases, thus honing the legal and personal skills that participants need to argue in front of international arbitration tribunals. Preliminary rounds will be held virtually via Zoom between while the advanced rounds (top 32 teams) will be held in-person in Riyadh, Saudi Arabia.
